## AGREEMENT OF INDEMNIFICATION AND WAIVER

In consideration of permitting the Indemnitor to occupy or utilize space ("License Area") in the interior or exterior common areas of the Hutchinson Mall (the "Center") for the purposes of the Show during the period listed above, Indemnitor hereby covenants with Southern Prairie Development, LLC ("Owner") and the Hutchinson Mall as the following:

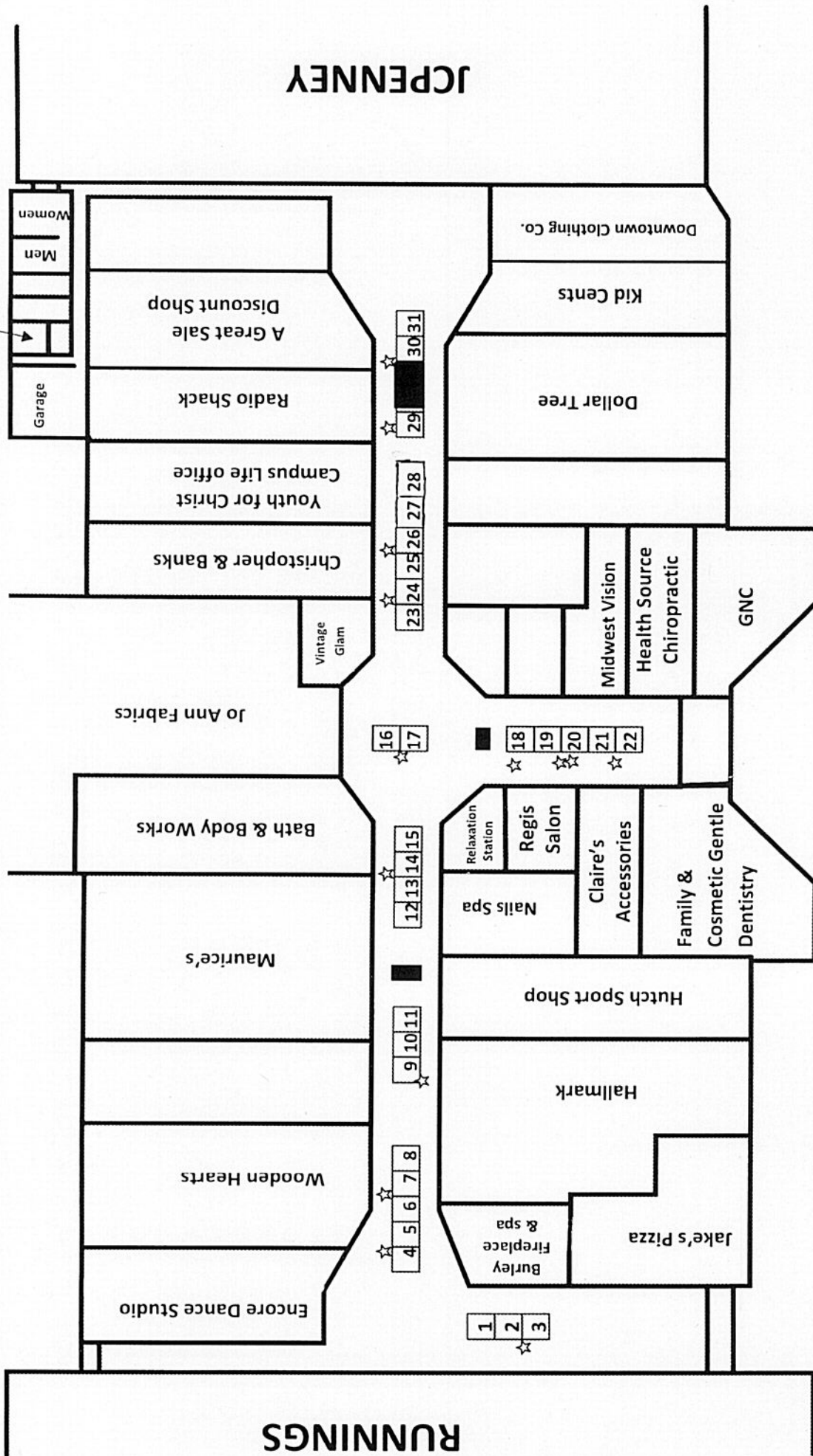
1. Indemnitor agrees to indemnify, defend and save harmless Owner and Merchants Association ("Association"), and their respective partners, shareholders, directors, officers, employees, agents, successors, assigns, guests, business invitees, tenants and other licensees, from and against any and all claims, actions, damages, liability and expenses (said expense to include a reasonable attorneys' fee) in connection with loss of life, personal injury and/or damage to property arising from or out of any occurrence in, upon or at the Licensed Area or any other portion of the Center by Indemnitor, its partners, shareholders, directors, officers, employees, agents, successors, assigns, guests, business invitees and other licensees and any other occupant or user thereof.
2. Indemnitor, its partners shareholders, directors, officers, employees, heirs, administrators, executors, beneficiaries, successors and assigns further agrees that neither Owner nor Association nor its partners, shareholders, directors, officers, employees, agents, successors, assigns, guests, business invitees, tenants and other licensees shall be liable to Indemnitor or to the occupant or user of all or any part of the Licensed Area for injury or death to persons, mysterious disappearance, theft, loss, damage or destruction of or to its and their personal property in the Licensed Area or the Center irrespective of the cause thereof and even though the same may have been caused or resulted in whole or in part by or from the negligent act or omission of Owner or Association or its or their agents and servants, and Indemnitor, its partners, shareholders, directors, officers, employees, heirs, administrators, executors, beneficiaries, successors and assigns hereby releases and waives all rights and claims against Owner and Associations and their respective partners, shareholders, directors, officers, employees, agents, successors, assigns, guests, business invitees, tenants and other licensees.
3. The officer signing this agreement for any corporate Indemnitor does hereby certify that the execution of this instrument has been authorized by appropriate action of its Board of Directors.
4. Notwithstanding anything to the contrary contained in this Agreement, Owner reserves the right to terminate this Agreement at any time and for any reason upon twenty-four (24) hours written notice to Indemnitor delivered to the kiosk premises, personal residence or such other place of business known to Owner.
5. The partner signing this agreement for any partnership, either general or limited, does hereby certify that execution of this instrument has been authorized by the partnership agreement.
